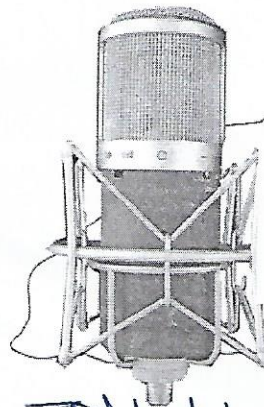

FREEDOM OF INFORMATION (FOI) REQUEST ON THE CONSTRUCTION OF FLOOD AND EROSION WORK AT HARMONY, FUNAAB AREA, ABEOKUTA

Rockcity 101.9 FM is the first independent radio station in Ogun State which since its establishment in 2007 has promoted citizens' participation in governance and provide voice for the people.

In collaboration with BudgIT, a Nigerian civic tech organization that applies technology for citizens engagement with institutional improvement to facilitate societal change, Rockcity 101.9 F.M is tracking some of the federal government projects in Ogun State. Aligning with Freedom of Information Act (FOIA) of 2011 and keeping with the transparency and accountability, we are requesting for the following information:

1. Documents showing list of companies involved in bidding for the flood and erosion control work at Harmony area, FUNAAB in Odeda Local Government Area.
2. Documents showing the criteria used for selecting successful company and eligibility for the contract.
3. Documents showing the budgeted amount for the project and the amount so far paid to the contractor awarded the project.
4. Documents showing assessment of completion of the project or rate of completion before payment was made to the contractor.

We are willing to pay for any fees, which are incurred as a result of complying with this request, but I remind you of the provision of Section 8 of the Act, which clearly states that fees "...shall be limited to standard charges for document duplication and fees transcription where necessary."

We trust that your prompt adherence to the Act requirements, in furnishing the requested information will enhance your standing in this year's FOI Compliance and Transparency Assessment.

We would appreciate if the information is made to us promptly but in any event, not later than 7 days from the date of receipt of this application, as required by the Freedom of Information Act 2011.
